This was described as a very lightweight, yet at the same time tough boot, very comfortable in wet and cold conditions and excellent performance (weight, foot support, comfort). Specially designed sole for the forest environment with good self-cleaning properties.

Comfort	The fit and comfort of the boot were rated very good. The boot was described as extraordinary light. Test persons rated "weight", "Comfort", "walking characteristics" and "fit" all excellent. Despite the good cushioning, the wearer can still feel the terrain very well.	Foot support is somewhat diminished in steep terrain.
Durability	The profile is tough and durable, no functional damage was noted during the test.	In some cases the edge of the rand came loose, but did not progress any further.
Features	The soles have good self-cleaning properties and provide good grip. Insulation and breathability were rated good.	The bootlaces were felt to be somewhat thin and sometimes the lacing came apart at the top hook
